Terms and Conditions

- Sandek Boarding Kennels & Cattery at their discretion reserves the right to refuse any animal.
- All Dogs must have a current C5 Vaccination Certificate, and a copy must be provided on arrival.
- All Cats must have a current F3 or F4 Vaccination Certificate, and a copy must be provided on arrival
- If your animal becomes ill or their behaviour becomes a danger to itself, humans or other animals Sandek Boarding Kennels & Cattery in its sole discretion, may engage the services of a veterinarian.
 - All attempts will be made to contact the Owner of the pet first; however, in the event of an emergency, the well-being of the pet will come first. Medication will be administered as necessary under the direction of a veterinarian. The owner gives the veterinarian complete Authority to treat the pet in whatever manner deemed necessary.
 - The owner will be responsible for all Veterinary charges upon release of the pet or upon request. Owner also gives full authority for the treating veterinarian and their associates to discuss with the Kennel any aspect of any illness or injury that the kennel has presented for treatment.
- The Pet Owner is responsible to pay all costs and charges incurred during and relating to the animals stay at Sandek Boarding Kennels & Cattery (including boarding fees, veterinary expenses, special services requested and any other charges incurred).
- The owner releases Sandek Boarding Kennels & Cattery, it's employees and agents from all liability for the injury, death, loss or damage of any kind whatsoever that may occur to the animal(s) while in the care of, or being transported by, or directly being supervised by Sandek Boarding Kennels & Cattery, it's employees and agents.
- If the animal is not collected within 14 days of the departure date given when the animal was checked in, and there has been no word from the owner to make suitable arrangements for the dog to be collected. The animal will become the property of Sandek Boarding Kennels & Cattery and the owner gives permission for Sandek Boarding Kennels to dispose of the animal(s) as seen fit.
- Payment is expected at the time of checkout. The owner must pay the rate of
- boarding in effect on the date the pet is checked into the kennel.



- Pets picked up after 12.00 (noon) will be charged the full boarding for that day.
- If the animal(s) to be boarded for a longer period of 1 month or for an indefinite period, a credit card authorisation and number must be supplied to allow us to take weekly boarding payments.
- Pet Owner authorises Sandek Boarding Kennels & Cattery to use pictures of their pet taken while participating in Kennel activities on its website and in other promotional materials.
- Should any animal be found hosting fleas, the person responsible for collecting the animal will at the time of collection, be liable for all cost of treating the animal and surrounding environment considered necessary by Sandek Boarding Kennels & Cattery.
- It is stressed that all dogs be on a secured lead at all times (collars being worn must be secure so they cannot slip loose) when the owner brings them or takes them home, as we accept no responsibility for loss or injury. If the owner insists on not putting a lead on then it is then the responsibility of the owner.
- Check chains (choker collars) must be removed before placing dog in to its kennel.
- It is stressed that all cats and all small animals must be in a secure basket/carrier at all times when owner brings in and when collected as we accept no responsibility for loss or injury.
- Whilst in our care no animal(s) will be allowed visitors as this can upset them.
- Beds, bedding and toys are not required (as we can supply them) but if you would like to bring beds, bedding, toys etc. Then we accept no responsibility for loss or damage to customers belongings. Any destroyed or soiled will be disposed of.
- Pet owners will be liable for any damage inflicted upon staff or property by their animal(s).
